



Concrete Coatings Slip Resistant Additive 3001-XXXX

Previously ICI Paints GROUNDWORKS™ Slip Resistant Additive

DESCRIPTION

A finely ground polymer material to be added to paint, concrete stains or sealers to achieve a slip resistant surface on walkways, driveways, garage floors, patios, pool decks and other horizontal surfaces.

DIRECTIONS FOR USE

Designed to be incorporated into a suitable paint, concrete stain or sealer. Minimum inclusion ratio of 3001 Concrete Coatings Slip Resistant Additive is as follows: .18 lbs bottle to a gallon can or .88 lbs bottle to a five-gallon pail. More may be added depending on the desired texturing effect, but not to exceed .36 lbs (6oz) per gallon. While continually stirring, add 3001 Concrete Coatings Slip Resistant Additive to the container of paint, concrete stain or sealer. It may tend to float at first, but once wet it will mix in easily. Occasional stirring, during application, may be required in thinner products to keep the particles well suspended within the coating. Follow application instructions of the paint, concrete stain or sealer. Use of this additive in materials should be for additional slip resistance as a safety measure and should not be used in place of a nonskid finish.
